Get a \$50 bonus when you sign up for Direct Deposit of Payroll/Retirement Income within 60 days of opening your account. Once all promotional requirements are met, the \$50 bonus will be deposited into your Interest Checking Account within 30 days of receipt of the first Direct Deposit of Payroll/Retirement Income. The \$50 bonus is available only on your first Interest Checking Account and will only be paid once. Bonus is considered taxable income and will be reported to the IRS on your 1099-INT form. Interest Checking Account earns dividend when daily balance is \$750 or more. This is a variable rate account and the APY could change after the account is opened. No monthly fee for one year and thereafter with Direct Deposit or a \$750 minimum. \$7 otherwise.

There is a \$12 monthly fee on the Premium Money Market Account when the daily balance falls below \$25,000 at any time during the month.
